Both of these are for background purposes, and together with the lecture, they should help you get a better overview of the course. You should plan on reading them again as a review and to help tie the course together.

For the first class, read the problem, read all the questions, and THINK hard about the answers to the first ten of them. Do not do any research; the object is not to get to the right answer but to think about how a set of rules might approach these questions. My experience is that students & rules do not mix well together, especially at the start of law school. This exercise is designed to help you understand that rules are not created (just) to annoy students, but have purposes and solve problems, which means that you have to understand the basic reason for having the rule and its overall approach before you can start to apply it to concrete situations. The assignment also shows the interconnections among the rules, both in interpreting similar provisions and in showing how one rule does not (and need not) solve all problems in litigation, because there are other rules to help out. Finally, rules are often not neutral, but help one side or the other, which means they involve tradeoffs of both substance and form. I will return to these points during my overview, and the class discussion will return to them regularly. Hopefully, the lessons that the problem will teach will help throughout the semester and beyond.
